

RULES FOR THE ANNUAL MEETING PRIZE DRAWINGS

1. **INFORMATION:** Registering at Santee Electric Cooperative's (SEC) Annual Meeting guarantees your name is placed in the prize drawing. The prize drawing will happen at the end of the Business Meeting that is streamed live from SEC's Facebook. A list of the winners will be posted to SEC's website the next day. Winners will be contacted by phone, email, or postal mail.
2. **LIMITATIONS OF LIABILITY:** SEC assumes no responsibility for (a) any incorrect or inaccurate entry information or for any faulty or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction, or alteration of, entries at any point in the operation of the prize drawing; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation, or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers, or providers utilized in any aspect of the operation of the prize drawing; (d) inaccessibility or unavailability of the SEC website; or (e) any injury or damage to entrants or to any other person's computer which may be related to or resulting from any attempt to participate in the prize drawing or download of any materials about the prize drawing. If, for any reason, the prize drawing is not capable of running as planned for reasons that may include, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes that may corrupt or affect the administration, security, fairness, integrity, or proper conduct of the prize drawing, then SEC reserves the right at its sole discretion to cancel, terminate, modify, or suspend the prize drawing in whole or in part.
3. **RELEASE:** All entrants, as a condition of entry into the prize drawings, agree to release SEC, participating sponsors, their subsidiaries, divisions, affiliates, suppliers, printers, distributors, and advertising, promotional, or judging agencies, from and against any and all liability, claims or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with participating in any aspect of the prize drawings, the receipt, ownership or use of any prize awarded, or while preparing for, participating in or traveling to or from any prize-related activity, or for any

typographical or other error in these award rules or the announcement or offering of any prize. Except for where prohibited by law, the winner grants to SEC the right to print, publish, broadcast, and use worldwide in any media now known or hereinafter known (including without limitation use of SEC's website) the winner's name, address, voice, statement, picture, or other likeness, without additional compensation, for public relations, advertising, and promotional purposes as may be determined by SEC.

DISPUTES: As a condition of participating in the prize drawing, the entrant agrees that any and all disputes which cannot be resolved between the parties and causes of action arising out of or connected with this prize drawing, shall be resolved individually, without resort to any form of class action, exclusively before a court located in South Carolina having jurisdiction. Further, in any such dispute, under no circumstances will the entrant be permitted to obtain awards for, and hereby waives all rights to claim, punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than the entrant's actual out-of-pocket expenses (i.e., costs associated with entering the prize drawing), and entrant further waives all rights to have damages multiplied or increased.
