**THE TWO WEEKS** of preparation and restoration for Hurricane Matthew now seem like a blur. Everyone at Santee

Electric worked non-stop, yet tirelessly, to restore electric service to our entire fourcounty service territory.

It was a long, hard slog. The cooperative's 2,005-squaremile service area is the largest of any electric co-op east of the Mississippi River. More

than 5,500 miles of power line stretch across the territory, often through farm fields, woods and swamps. Stretched into a single line, the system would reach California and back.

Finally, a week after Matthew struck, we could see the light at the end of the tunnel as we drew near restoring power back for most of our members. I felt a surge of pride in our employees. Their dedication, commitment to serve, and pure hard work was remarkable, both during the preparation for and the recovery from Matthew.

It proves once again that Santee Electric is more than a utility that provides electricity to our members. It shows the value of having employees who are local residents, involved in the communities where they live and work. Like local law enforcement and other first responders, they are there when you need them.

I'm also proud of Santee's extended co-op family, which includes our state association, the Electric Cooperatives of South Carolina, Inc., the 19 other distribution co-ops in South Carolina, and our power supply aggregator, Central Electric Power Cooperative, as well as our utility supply co-op, CEE-US. All worked together, coordinating resources to help us.

And, thanks to mutual aid agreements that electric co-ops have in place before natural disasters or other emergencies occur, Santee received help from co-ops in Alabama, North Carolina, Virginia, Maryland and Kentucky. Hundreds of lineworkers came to help get your lights back on. Cooperation among co-ops is a cooperative principle, and we'll be there for our co-op friends when they need us.

We also thank Santee Cooper, the state-owned utility that generates most of the power we distribute, as well as our contractors and vendors, for their help. But most of all, we thank our members. You demonstrated patience and understanding, and countless acts of kindness, in the aftermath of the storm.

As life gets back to normal for most of us, please don't forget the local residents and businesses that were not as fortunate. Many people have a lot of challenges ahead. Please keep them in your thoughts and prayers.
